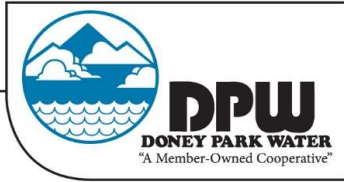

Its purpose is to help identify potential backflow hazards that could affect the safety of your drinking water and the public water supply.
